Minutes of Previous Meeting

Minutes of the previous meeting were read by the Secretary.

Treasurer's Report

Operations Report

Shane desires that rulings, rules, policies, and protocols adopted by the Board be communicated to the membership, followed-up, carried out, and enforced. Joe Parrish will take responsibility for updates to the Operations Manual. Your Secretary will undertake to pass along the original computer files containing the text of the manual to Joe.

Events

Joe Parrish is coordinating this event and is soliciting any suggestions, comments, and volunteers to help out at the field on that day. All should have received the flyers Joe mailed out by

now. This event is just what the title suggests, a day of fun! If you didn't make it out last year, you should know that a great time was had by all! It is an excellent way to meet and get to know your fellow members, have some fun flying and eat some good food.

The New Market Community Day looms ever closer...June 10th! This was an event originally suggested by Spencer Annear last year. Now, however, there is a Pilot's Association at New Market, a hot air balloon dealer/instructor, and a sky diving outfit. All of the above plan to participate in some way at this "big event."

We plan to offer free rides to the public on a first come, first served basis. We will need wing runners, glider retrievers (using the club's tow car), pilots to fly the guests and so on. Joe Parrish is going to do some advertising for this event as far as it concerns *Skyline Soaring*. A motion was made, seconded and passed by voice vote to appropriate up to \$50.00 to pay for the advertising.

More planing will be done at next month's Board meeting. There will also be a special meeting after the **Fun Day** on **May, 13th** at the airport to do some planning for **June 10th's Community Day**.

Old Business

The annual Safety Meeting was talked about and a motion was made/seconded and passed by voice vote to appropriate up to \$25.00 for door-prize(s) to be given away at this meeting.

Talked about the trailer again. Shanes has some volunteers, but needs more. This promises to be a good deal of work. He plans to set up the trailer to carry Schweitzer aircraft, which will entail a/c disassembly and assembly as well as work on the trailer itself.

The New Market Pilot's Association's Newsletter was read to the Board. Jim McCulley reported that he had attended the last meeting held and had laid out our views/plans for the Community Day on June 10th to the association. Some there were under the mistaken impression that this activity was their idea, but that was put to rest by Jim.

Things are progressing with getting the new candidate for tow pilot and member, Schallenberger, checked out as a

tow pilot to meet our insurance carrier's rules.

Next there was a great deal of discussion on the subject of Duty Officer "no shows."

The upshot of this discussion was two motions made, seconded and passed by voice vote to recruit a Chief Duty Officer and to have them report to our Vice President and Safety Officer, Shane Neitzey.

New Business

The Civil Air Patrol has written to the club wanting an arrangement to have Flight Camps with Skyline Soaring hosting at the airport.

The club will offer Trial Memberships at \$20.00 each for the CAP cadets with regular charges for any flights made. Volunteer pilots from the club would do the flying or instructing. Spencer Annear will communicate this back to the CAP.

Joe Parrish will speak to Jim Miklejohn of the Mid-Atlantic Soaring Association (M-ASA). We have talked, off and on, with that organization about this, but to no avail. It seems that now there may be an opening, since there has been changes in their Board of Directors due to elections, which make some agreement possible. Joe will try to arrange a joint board meeting.

The next board meeting is set for May 25, 1995 at Manassas Park at 7:00 P.M.

Club News

Soaring Achievements

Joe Parrish, as you know, achieved his FAI Gold Altitude badge leg at the Wave Camp in Petersburg, WV. The announcement appeared in the May 1995 issue of *Soaring* magazine. Again, congratulations, Joe!

Also, in the same issue, Kevin Fleet was mentioned for his attaining the SSA A badge. Congratulations to you also, Kevin!

Topping off the soaring achievements by SSC members, Bela Gogos, our Treasurer, has achieved his FAI Diamond Badge! Bela was able to climb to an altitude of 28,000 feet out of Minden, NV on his successful attempt. This happened on April 25, 1995. Bela says it was 4,000 feet more than he needed to complete his third badge leg. This is a gain of 5,000 meters (16,404 feet) from the start point. The other legs for this badge were Diamond Distance on May 21, 1989 and Diamond Goal on April 25, 1991.

Congratulations are in order to Bela for this outstanding performance. Bela was officially notified that on April 30, 1995 he was awarded

Diamond Badge No. 806. This can be put in perspective if you know that badge 803 was just awarded to Eric Mozer. For any who do not know who Eric is, suffice to say he is a world class competition soaring pilot! These badges are numbered sequentially as they are given out. That means that Bela's is the 806th issued to a U.S. pilot! Quite an exclusive fraternity of flyers. He will be notified when the international number is assigned. This award puts Bela in a class of pilots (those of us who know and fly with him aren't surprised) of world renown.

Planning for Club Activities

Spencer Annear has requested that anyone who is interested in getting together for a trip to the hyperbaric chamber at Andrews Air Force Base in Maryland contact him and he will compile a list. If enough are interested, he will arrange a session for us.

For those who might not be familiar with this program, the FAA in cooperation with the military provide training in the physiology of high altitude flight complete with classroom sessions and time in the "high altitude" chamber used for training military personnel. This is done at a minimal expense to participants to familiarize and train you in the effects of high altitudes on the human body, how to recognize the onset of hypoxia, and the effects on each pilot personally. Not all react

the same way at the same times to oxygen deprivation. The training requires an FAA Class III Medical to participate.

A 50th Year, Since the End of World War II, Commemorative Flight to be Made during August 1995

A 50th year since the end of World War II commemorative flight of about 500 restored "warbirds" will be participating in the "Freedom Flight America" from the west coast to the east during August this year. On August 9th the Winchester Chapter of the Air

Force Association (Chapter 435) and the management of the Winchester Regional Airport are hosting the arrival of a number of these historic aircraft. About 30-40 of these planes will land at Winchester on the 9th. They will be stopping for refueling and "mess call," to feed the crews. The hosts are asking that any WW II veterans who are interested contact them. These veterans will be invited to "luncheon mess" with the pilots and crews of these historic aircraft.
